The Iligan City Government Bids and Awards Committee(BAC) invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Brief Description: Consultancy Services for the Architectural and Engineering Design Services in Preparation of Bidding Documents, Technical Specifications and Parameters, Conceptual Design, Pre-Bidding Documents and Rendering of Project Management for the PROPOSED CONSTRUCTION OF NEW PALA-O PUBLIC MARKET BUILDING, Pala-o, Iligan City.

Contract Duration: 75 Calendar Days

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specific in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens of the Organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Iligan City Government and inspect the Bidding Documents during office hours from 8:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m. at the Office of the Bids and Awards Committee, 2nd Floor City Hall Main Bldg., Buhanginan Hills, Pala-o, Iligan City.

The BAC will issue Eligibility Documents to prospective bidders at BAC Office 2nd flr. City Hall main Bldg. Buhanginan Hills, Pala-o, Iligan City upon submission of Letter of Intent(LOI).

A complete set of Bidding Documents with **TOR** in Section VI will be available to eligible bidders upon payment of a non-refundable amount of **Twenty Five Thousand Pesos (P 25,000.00)** to the City Treasurer's Office, Iligan City.

The Bid must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in BDS Clause 15.1.

The BAC shall draw up the short list of consultants from those who have submitted Expression of Interest, including the eligibility documents, and have been determined as eligible in accordance with the provisions of Republic Act 9184(RA 9184), otherwise known as the "Government Procurement Reform Act", and its Implementing Rules and Regulations (IRR). The short list shall consist of Five (5) Consultants/prospective bidders who will be entitled to submit bids .

The **criteria** and **rating system** for short listing is in Section III of Eligibility Documents .

Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the IRR of RA 9184.

Bidding is restricted to Filipino citizens/sole proprietorship, cooperatives, and partnerships or organizations with at least sixty percent(60%) interest or outstanding capital stock belonging to citizens of the Philippines.

The Procuring Entity shall evaluate bids using the **Quality Based Evaluation (QBE)** procedure.

The contract shall be completed within Seventy Five (75) calendar days.

A Bids must be open in the presence of the bidders' representative who chooses to attend at the above-stated address. Late bids shall not be accepted.

The Iligan City Government reserves the right to accept or reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.

Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bid.
