Frontline service	:	CONDUCT OF ANTE-MORTEM AND POST MORTEM MEAT INSPECTION
Availability of the service	:	Ante-Mortem , 7 AM to 7 PM – Monday to Sunday Post Mortem , 8 AM to 12 NN; 10 PM to 3 AM Monday to Sunday
Who may avail of the service	:	Meat dealers, and General Public <i>(all livestock to be butchered for meat SHALL be slaughtered only at the City Abattoir - RA 9296 and CO 3146)</i>
What are the requirements	:	Livestock for slaughter must be legally-owned by the client, in good health, stress-free and not pregnant; vehicles used to pick-up carcasses and offals must have proper containers
