

## INVITATION TO BID

The Iligan City Government Bids and Awards Committee(BAC) invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

**Name of Project** : **PROPOSED EVACUATION CENTER (IMPROVEMENT OF BLEACHERS),**

**Location** : Dalipuga Auditorium, Barangay Dalipuga, Iligan City

**Brief Description** : To provide labor, materials and equipment for Work includes the following activities such as demolition, cleaning, removing, disposing of all vegetations, debris structures & all obstructions affected by the said construction, staking, lay-out of lines, grades & elevation of the structures to be improved; excavation work for footing, column, wall footing foundation; Backfilling; concrete work, formworks & scaffolding for columns, roofbeams, slab, bleachers; CHB walling includes plastering and finishing only at side of proposed stair A; Concreting and formworks, steel roof framing structure and Tinsmith for Bleachers structure; Bleachers structure; ITEMS NOT INCLUDED such as backfilling, Roof framing, Tinsmith for sidewalk, C.R. He & She, Female dressing room, kitchen, feeding room; plumbing, painting, tilework, electrical, sidewalk, doors and windows; all comfort rooms, dressing room, kitchen and feeding room. Note: Please provide all necessary safety measures to protect the structure, adjacent properties, construction safety for workers & other persons during in all phases of Construction; as per mandated by DOLE D.O. No. 13; Please implementing the provision of Batas Pambansa B.P. 344.

**Approved Budget for the Contract** : **P 1,099,999.92**

**Contract Duration** : **80 Calendar Days**

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specific in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens of the Organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Iligan City Government and inspect the Bidding Documents during office hours from 8:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m. at the Office of the Bids and Awards Committee, 2<sup>nd</sup> Floor City Hall Main Bldg., Buhanginan Hills, Pala-o, Iligan City.

The Bid must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in BDS Clause 18.1.

A Bids must be open in the presence of the bidders' representative who chooses to attend at the above-stated address. Late bids shall not be accepted.

**All required documents shall be tag in accordance with the sequence. Failure to comply shall be automatically disqualified.**

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bid.
