

INVITATION TO BID

The Iligan City Government Bids and Awards Committee(BAC) invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Name of Project : **REPAIR & IMPROVEMENT OF 7-CLASSROOM BUILDING**
Contract Ref. No. : **INFR-18-016**
Location : Ditucalan Elementary School (ES), Barangay Ditucalan, Iligan City

Brief Description : To provide labor, materials and equipment for Removal of existing structure such as ceiling boards and joist, wooden walling, doors and windows to be replaced and concrete slab affected by the introduction of wall footings for CHB wall (front and Rear Elevations); Excavation work for wall footings; Concrete work, formworks and scaffoldings for wall floorings, beams and slabs; Masonry works using 4" thick CHB (Replacing existing wooden wall at front and rear elevations); double walling of partitions using marine plywood and 50mm x 50mm Gimelina lumber studs; fabrication and installation of steel reinforcement for wall footings. Beams and slabs (replenishing the demolished portions for the wall footings); fabrication and installation of wooden air vents; installation of hardilite ceiling boards by metal furring; fabrication and installation of steel grill windows; fabrication and installation of structural steel for trusses and purlins; installation of hardiflex ceiling boards supported by metal furring and carrying channel bars; installation of electrical rough-ins and fixtures; painting works (primer plus 2 coatings) for existing roofing, new ceiling, old and walls, steel grill windows, doors and door jambs and metal primer only for ceiling metal furring and angle bars.

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specific in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens of the Organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Iligan City Government and inspect the Bidding Documents during office hours from 8:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m. at the Office of the Bids and Awards Committee, 2nd Floor City Hall Main Bldg., Buhanginan Hills, Pala-o, Iligan City.

The documents required for the Eligibility shall be submitted as part of the Technical Documents / Proposal of the Bidders as provided in the Instructions to Bidders. List of Eligibility and Technical requirements is in Section 9 of the Bidding Documents.

A complete set of Bidding Documents will be available to prospective bidders upon payment of a non-refundable amount of **One Thousand Pesos (P 1,000.00)** to the City Treasurer's Office, Iligan City.

The Bid must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in BDS Clause 18.1.

A Bids must be open in the presence of the bidders' representative who chooses to attend at the above-stated address. Late bids shall not be accepted.

All required documents shall be tag in accordance with the sequence. Failure to comply shall be automatically disqualified.

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bid.
