**Brief Description** : To provide labor, materials and equipment for Removal of dilapidated and pot holed roofing sheets and bended accessories; Installation of 0.50mm thk. corrugated roofing, 0.50mm thk. Prefabricated ridge rolls, roof gutters, end flashing, fastened w/ tex screw and other accessories; Painting works (epoxy primer-1 coat & 2 coats-epoxy paint) on all steel components and roofing sheets; cleaning and disposal of construction debris materials at project site; Proper turn-over.
