

INVITATION TO BID

The Iligan City Government Bids and Awards Committee(BAC) invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Name of Project : **IMPROVEMENT OF ROAD AND DRAINAGE ALONG MIGUEL SHEKER AVENUE (FROM NATIONAL HIGHWAY TO CHILDREN'S PARK**
Contract Ref. No. : **INFR-19-001(CEO)**
Location : **Barangay San Miguel, Iligan City**

Brief Description : To provide labor, materials and equipment for Staking, layout of lines, grades and elevation of roadway to be concreted; removal of structures and obstruction/disposal; excavation of trench canal for utility/ service pipes, etc.; subgrade preparation by grading/scarifying and compacting of roadway; placement/installation of utility/service pipes w/ joint mortar; placement of aggregate base course and later on road shoulders (graded and compacted in accordance w/ the lines, grades & elevation); fabrication/installation of side forms and dowel bars; concreting of road, L=616.50 lineal meters, width = 6.10 mts. & thickness = 200mm, w/ 12mm Dia. X 600mm interval on center lines and edging of pavement and at every end of concrete pouring to include 20 units of chaplan; curing of concrete and removal of forms; Provide road/warning signs and project billboards; clearing/cleaning and removal of construction debris materials at the project site; turn-over of project.

Contract Duration : **103 Calendar Days**

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC.

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specific in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens of the Organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Iligan City Government and inspect the Bidding Documents during office hours from 8:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m. at the Office of the Bids and Awards Committee, 2nd Floor City Hall Main Bldg., Buhanginan Hills, Pala-o, Iligan City.

A complete set of Bidding Documents will be available to prospective bidders upon payment of a non-refundable amount of **Nine Thousand Pesos (P 9,000.00)** to the City Treasurer's Office, Iligan City.

The Bid must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in BDS Clause 18.1.

A Bids must be open in the presence of the bidders' representative who chooses to attend at the above-stated address. Late bids shall not be accepted.

All required documents shall be tag in accordance with the sequence. Failure to comply shall be automatically disqualified.

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders. Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bid.
