INVITATION TO BID (NEGOTIATED PROCUREMENT)

The Iligan City Government Bids and Awards Committee(BAC) invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Name of Project : **Construction of Four Classroom Building at Taluntunan Elementary School**

Contract Ref. No. : **INFR-19-008(CEO)**

Location : Taluntunan, Puga-an, Iligan City

Brief Description: To provide labor, materials and equipment for Staking and lay-out; Excavation work for footings, wall footing, tie beams and septic tank; Concrete works, formwork and scaffoldings for footings, wall footings, columns, beams and slabs; Masonry works using 4" thick CHB; fabrication and installation of steel reinforcement for footings, columns, slabs and CHB walls; fabrication and installation of doors and windows; fabrication and installation of structural steel for trusses and purlins; Installation of hardiflex ceiling boards supported by metal furring and carrying Channel bars; Installation of Ordinary corrugated colorsteel sheets for roofing, plain colorsteel pre-fabricated gutters, fascia sheets, wall flashing and ridge roll; Installation of plumbing rough-ins and fixtures; Installation of electrical rough-ins and fixtures; installation of ceramic tiles for CR flooring and ceramic tiles for lavatories and comfort rooms; Painting works; supply of door knobs, loose pin hinges and other const. materials for the installation of wooden doors.

Contract Duration: 180 Calendar Days

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specific in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens of the Organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC.

Interested bidders may obtain further information from Iligan City Government and inspect the Bidding Documents during office hours from 8:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m. at the Office of the Bids and Awards Committee, 2nd Floor City Hall Main Bldg., Buhanginan Hills, Pala-o, Iligan City.

The documents required for the Eligibility shall be submitted as part of the Technical Documents / Proposal of the Bidders as provided in the Instructions to Bidders. List of Eligibility and Technical requirements is in Section 9 of the Bidding Documents.

A complete set of Bidding Documents will be available to prospective bidders upon payment of a non-refundable amount of **Five Thousand Pesos (P 5,000.00)** to the City Treasurer's Office, Iligan City.

The Bid must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in BDS Clause 18.1.

A Bids must be open in the presence of the bidders' representative who chooses to attend at the above-stated address. Late bids shall not be accepted.

All required documents shall be a tag in accordance with the sequence. Failure to comply shall be automatically disqualified.


