### INVITATION TO BID

The Iligan City Government Bids and Awards Committee (BAC), invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Name of Project : **Well Drilling Works/Exploration of New Production Well**  
Location : **Barangay San Roque, Iligan City**  
Contract Ref. No. : **INFR-19-028**

Brief Description : **Well Drilling Works: 1. Mobilization of Drilling rig, crew & accessories to site; 2. Site preparation, setting up rig, digging of mudpit & waterways; 3. Drilling by rotary method of 200mm (8") dia. Pilot hole including collection of soil sample every 1m. penetration; 4. Electric logging of pilot hole including preparation of final well design; 5. Reaming to 450mm (18") dia. final borehole; 6. Supply of 12"dia BI welded pipe 6.0mm min. thickness; 7. Perforation of well casing; 8. Installation of well casing screens; 9. Supply & installation of gravel packing with pebbles 3-6mm dia.; 10. Supply & installation of 2"dia gravel-fill pipe, sounding tube, etc.; 11. Development of well by application of polyphosphate solution; 12. Development of well by surging & bailing out of settlements; 13. Pumping test: constant rate discharge test; 14. Cement grout sealing of annular space around well casing; 15. Clean up of drilling site & demobilization & 16. Approval of Water Rights Permit (includes the application of Processing of Water Rights Permit Fees for Approval to NWRE).**

Approved Budget for the Contract : **P1,514,761.50**  
Contract Duration : **45 Calendar Days**

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC.

Interested bidders may obtain further information from Iligan City government and inspect the Bidding Documents during office hours from 8:00 a.m. – 12:00 p.m. and 1:00 p.m. – 5:00 p.m. at the Office of the Bids and Awards Committee, 2<sup>nd</sup> Floor CASSO Bldg., Buhanginan Hills, Pala-o, Iligan City.

Bids must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in the amount stated in BDS Clause 18.1.

Bids will be open in the presence of the bidders' representative who choose to attend at the above-stated address. Late bids shall not be accepted.

All required documents shall be tag in accordance with the sequence. Failure to comply shall be automatically disqualified.

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bids.
