The Iligan City Government Bids and Awards Committee(BAC) invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Brief Description: To provide labor, materials, and equipment for Carpentry works including exterior and interior wall sidings, ceiling and floor joist; Tile works; Tinsmithry works for roofing; Painting works; Plumbing works; Electrical works.

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens of the Organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Iligan City Government and inspect the Bidding Documents during office hours from 8:00 a.m. to 12:00 noon and 1:00 p.m. to 5:00 p.m. at the Office of the Bids and Awards Committee, 2nd Floor City Hall Main Bldg., Buhanginan Hills, Pala-o, Iligan City.

All required documents shall be a tag in accordance with the sequence. Failure to comply shall be automatically disqualified.

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
