A complete set of Bidding Documents will be available to prospective bidders upon payment of a non-refundable amount of **Five Thousand Pesos (P 5,000.00)** to the City Treasurer's Office, Iligan City

All required documents shall be tag in accordance with the sequence. Failure to comply shall be automatically disqualified.


