INVITATION TO BID

The Iligan City Government Bids and Awards Committee (BAC), invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Name of Project : **Construction of Two (2) Storey Medical Records Building**
Location : **GTLMH Compound, Pala-o, Iligan City**

Brief Description : **Earthworks: Excavation of wall footing, column footing and zocalos, gravel bedding, backfilling 20% Soil compaction, clearing, grubbing, removing and disposing all vegetations debris and all obstruction; concrete works, formworks and scaffoldings, Installation of forms and scaffoldings for columns and beams by using assorted sizes of coco lumber ord. plywood & assorted sizes of CW nails; Masonry works and concreting of column, footing, beams and slab; Steel Reinforcement using 20mm dia. DSB for vertical bars for column, 16mm dia DSB bed bars for footing, 16mm dia. DSB horizontal reinforcement for floor and roof beams. 12 mm dia. DSB for slab, 10 mm dia. for wall footings and zocalo; Steel works: using 0.80 mm thk. Long span steel deck, 50 mm x 50 mm x 6 mm thk. & 38 x 38 x 4.5 mm thk. Angle bars for truss, 50 x 100 x 1.50 mm thk. C-Purlins, 50 mm dia. Stainless pipe for railings for stair; Plumbing works Installation of water closet with complete accessories, lavatory w/ complete accessories, 4" & 2" dia. PVC pipe for soil and waste water pipes, 1/2" dia. GI pipe for water lines; Electrical works: using 2.0 mm², 3.5 mm², 5.5 mm² & 8.0 mm² Copper Wire for electrical wirings, 15A, 20A, 100A Plug-in type Circuit Breaker and 9W & 18W LED bulb..**

Approved Budget for the Contract : **P3,757,959.56**
Contract Duration : **120 calendar days**

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Bidding is open only to those who have a Business Permit issued here in Iligan City.

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC.

Interested bidders may obtain further information from Iligan City government and inspect the Bidding Documents during office hours from 8:00 a.m. – 12:00 p.m. and 1:00 p.m. – 5:00 p.m. at the Office of the **Bids and Awards Committee, 2nd Floor CASSO Bldg., Buhanginan Hills, Pala-o, Iligan City.**

The documents required for the Eligibility shall be submitted as part of the Technical Documents/Proposal of the Bidders as provided in the Instruction to Bidders. List of Eligibility and Technical requirement is in Section 9 of the Bidding documents.

A complete set of Bidding Documents will be available to prospective bidders upon payment of a non-refundable amount of **Five Thousand Pesos (P5,000.00)** to the City Treasurer's Office, Iligan City.

Bids must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in the amount stated in BDS Clause 18.1.

Bids will be open in the presence of the bidders' representative who chooses to attend at the above-stated address. Late bids shall not be accepted.

All required documents shall be tag in accordance with the sequence. Failure to comply shall be automatically disqualified.

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bids.
