### INVITATION TO BID

The Iligan City Government Bids and Awards Committee (BAC), through **General Fund-Proper CY 2016** intends to apply the sum of **P 3,000,000.00** being the Approved Budget for the Contract (ABC) to payments under the Contract for **Supply and Delivery of Patient Transport Vehicle** with Project Reference No. **CB(B)20-032(CMO-ICDRMO)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The Iligan City Government Bids and Awards Committee now invites for the supply and delivery of items below-stated:

**APPROVED BUDGET FOR THE CONTRACT (ABC): P 3,000,000.00**

**PARTICULARS: 1-unit of Patient Transport Vehicle with ambulance equipment and accessories, etc.**

**REQUIRED BID SECURITY:** 2% of the ABC if Cash, Manager's Check; Bank Draft/Guarantee, Irrevocable letter of credit confirmed or authenticated by a Universal or Commercial Bank; and 5% of the ABC if Surety Bond callable upon demand issued by a surety or insurance company duly certified by the Insurance Commission as authorized to issue such security

Delivery period is within ten (10) calendar days from receipt of Notice to Proceed. Bidders should have completed, within Five (5) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instruction to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from Iligan City government and inspect the Bidding Documents during office hours from 8:00 a.m. – 12:00 p.m. and 1:00 p.m. – 5:00 p.m. at the Office of the Bids and Awards Committee, 2<sup>nd</sup> Floor CASSO Building, Buhanginan Hills, Pala-o, Iligan City.

Bidding is open only to those who are registered and accredited supplier by the Bids and Awards Committee. Registration fee of 3,000.00 per Annum.

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bids.
