INVITATION TO BID

The Iligan City Government Bids and Awards Committee (BAC), invites contractors registered by the Philippine Contractors Accreditation Board (PCAB) to bid for the hereunder contract:

Name of Project : **Completion of City Assessor's Building**
 Location : **Buhanginan Hill, Barangay Pala-o, Iligan City**
 Contract Ref. No. : **INFR-21-030**
 Brief Description : **Staking, lay-out of drainage line along CASSO Extension building with outflow going to existing drainage line, excavation works, removal of obstruction; cutting/ bending of steel reinforcements intended for concrete and masonry structures; masonry structures; masonry works using 6"x8"x16" concrete hollow blocks for catch basin and 4"x8"x16" concrete hollow blocks for drainage line w/ 10mm dia rebars spaced at 600mm on center for bothways (plastered finish on canal surface only, smooth); installation of PVC doors for CR; installation of metal frames ceiling joists w/ 5mm marine plywood cover; tileworks for 2nd floor, CR, CR walls & counter to include stair way from ground floor to roof deck w/ 600mm x 600mm non-skid tiles; complete plumbing works (including installation of water pump, accessories & stainless steel water storage tank); complete electrical works (2nd floor area); painting works (primer 1 coat & 2 coats final); removal of water damage door jambs, doors at exit and CR; covering of exit w/ CHB, w/ rebars & plastered finish (painted); converting of CR into storage room w/ wooden door; removal and proper disposal of construction debris materials at project site; proper turn-over, provide adequate safety signages and warning signs.**

Approved Budget for the Contract : **P43,115.03**
 Contract Duration : **102 Calendar Days**

Bidding will be conducted through open competitive bidding using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA9184), otherwise known as the "Government Procurement Reform Act". Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino Citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Bidding is open only to those who have a Business Permit issued here in Iligan City.

Prospective bidders should possess a valid PCAB License applicable to the contract, have completed a similar contract with a value of at least 50% of the ABC.

Interested bidders may obtain further information from Iligan City government and inspect the Bidding Documents during office hours from 8:00 a.m. – 12:00 p.m. and 1:00 p.m. – 5:00 p.m. at the Office of the Bids and Awards Committee, 2nd Floor CASSO Bldg., Buhanginan Hills, Pala-o, Iligan City.

The documents required for the Eligibility shall be submitted as part of the Technical Documents/Proposal of the Bidders as provided in the Instruction to Bidders. List of Eligibility and Technical requirement is in Section 9 of the Bidding documents.

A complete set of Bidding Documents will be available to prospective bidders upon payment of a non-refundable amount of **One Thousand Pesos (P1,000.00)** to the City Treasurer's Office, Iligan City.

Bids must be delivered to the address and date above-stated. All bids must be accomplished by a bid security in any of the acceptable forms in the amount stated in BDS Clause 18.1.

Bids will be open in the presence of the bidders' representative who chooses to attend at the above-stated address. Late bids shall not be accepted.

All required documents shall be tag in accordance with the sequence. Failure to comply shall be automatically disqualified.

The Iligan City Government reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.

Furthermore, the City Government of Iligan assumes no responsibility whatsoever to compensate or indemnify bidders for any expense or loss incurred in the preparation and submission of the eligibility statements and bids.
